PATENT

- Patent law protects inventions and improvements to inventions
- Patent protection is governed by federal, not state law
- Patent protection depends on registration
- The United States Patent & Trademark Office (USPTO) determines whether patents are issued
- Patent Trial & Appeal Board (PTAB) hears appeals from adverse decisions on patentability and *inter partes* disputes
- Federal Circuit has exclusive jurisdiction over appeals in patent cases since 1982, including appeals from district courts and PTAB







TRADEMARK

- Trademark law protects words, designs, or anything used in commerce to identify and distinguish the goods or services of one entity from those of another, and to indicate the source
- Trademark protection is governed by federal and state law
- Registration is not required for protection, but confers additional benefits
- The USPTO determines whether federal trademark registrations issue
- The Trademark Trial & Appeal Board (TTAB) of the USPTO hears appeals from adverse decisions on registrability and *inter partes* disputes



- The U.S. Copyright Office registers copyrights

RIGHT OF PUBLICITY

- Right of publicity protects "the right to control and to choose whether and how to use an individual's identity for commercial purposes" 765 ILCS 1075/10
- Right of publicity is governed by state law
- No government registration process

TRADE SECRET

- Trade secret is information, including technical or non-technical data, formulas, patterns, compilations, programs, devices, methods, techniques, drawings, processes, financial data, or lists of actual or potential customers or suppliers, that: (1) is sufficiently <u>secret</u> to derive <u>economic</u> <u>value</u>, actual or potential, from not being generally known to other persons who can obtain economic value from its disclosure or use; and (2) is the subject of efforts that are reasonable under the circumstances to <u>maintain its secrecy</u> or confidentiality. 765 ILCS 1065/2
- Trade secret protection is governed by federal and state law
- No government registration process






