


54. Plaintiff repeats and realleges each of the allegations set forth in Paragraphs 1 through 53 above as if fully set forth herein.

55. Dadon fraudulently and deceitfully obtained the Converted Shares by entering into an agreement to obtain Smart Corp. stock without any intention of fulfilling his obligations to Smart Corp.

56. Dadon, as Chairman of the Board of Directors of Smart Corp., issued to Dadon the Converted Shares, which have yet to be returned.

57. Dadon intended to defraud Smart Corp., as evidenced by his apparent continued pattern and practice of defrauding other companies, which resulted in, on information and belief, more than 20 lawsuits filed against him.

58. Dadon's fraudulent actions have caused damages to Smart Corp. in an amount of \$1,000,000.

Fastcase Cloud Linking is a free tool that finds citations to cases in your PDF or Word document, creates public hyperlinks to them, and returns the document (with links) to you as a download.
